Covington Road Trail - Hadley Road to Getz Road

The Bidder shall furnish all labor, insurance, equipment, materials and power for the complete performance of this project as follows:

That it is deemed necessary to improve: the north side of Covington Road from Hadley Road to Getz Road with an 8 to 10-foot wide asphalt trail, connecting Aboite residents with Covington Plaza and Time Corners. The project includes a pedestrian bridge, ADA curb ramps, retaining walls, signage, pavement markings, storm drainage infrastructure and erosion control measures.
