AN ORDINANCE approving RESOLUTION 98-8-3-11-3 - THE STONE LAKE STORM WATER EASEMENT AGREEMENT between STONE LAKE DEVELOPMENT, LLC. and the City of Fort Wayne, Indiana, by and through the Fort Wayne Board of Storm Water Management

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL

OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the RESOLUTION 98-8-3-11-3 APPROVING THE

STONE LAKE STORM WATER EASEMENT AGREEMENT by and between STONE

LAKE DEVELOPMENT, LLC. and the City of Fort Wayne, Indiana, by and through the Fort

Wayne Board of Storm Water Management, is hereby ratified, and affirmed and approved

in all respects, respectfully for:

Easement Agreement allows City Utilities to use the Stone Lake as a detention basin for stormwater management. The Easement Agreement also also allows the City to route area storm water from the Stone Lake Watershd and surrounding residential developments through public storm sewers into Stone Lake, and to reduce the rate of flow of stormwater to the river. The Easement Agreement brings all parties into compliance with the law:

involving a total cost of ONE HUNDRED SEVENTY-FIVE THOUSAND AND 00/100 DOLLARS (\$175,000.00) - (\$150,000.00 TO BE PAID UPON APPROVAL AND \$25,000.00 BY THE END OF THE FIRST QUARTER OF 2012). A copy said Easement

Agreement is on file with the Office of the City Clerk and made available for public inspection, according to law.

AN ORDINANCE AMENDING §50.09 GARBAGE USER FEE OF THE CITY OF FORT WAYNE, INDIANA, CODE OF ORDINANCES.

WHEREAS, the costs of collection, disposal, and processing of residential garbage and recycling are paid by contract wholly from the Solid Waste Fund; and

WHEREAS, the Solid Waste Fund is funded totally from the collection of garbage user fees on the monthly utility bills as well as from revenue received from the Recycle Processing Contract; and

WHEREAS, the contractual cost for the combined collection, disposal, and processing of garbage and recycling has decreased due to new contracts that went into effect January 1, 2011; and

WHEREAS, the Solid Waste Fund has a cash balance of \$3.6 million; and

WHEREAS, Common Council now finds the current garbage/recycle user fee of \$11.00 per month for a single family dwelling and \$22.00 per month for a residential building with two to four units can be lowered and still be sufficient to adequately fund the Solid Waste Fund.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE:

SECTION 1: That §50.09 Garbage User Fee. of the City
of Fort Wayne, Indiana, is hereby amended as
follows:

§50.09 Garbage User Fee

- (I) The monthly single-family residential household fee shall be \$9.95 per month, effective September 1, 2011.
- (J) The monthly multi-family two-to-four residential unit household fee shall be \$19.90 per month, effective September 1, 2011.
- **SECTION 2.** That this Ordinance shall be in full force and effect from and after September 1, 2011, contingent upon its passage and any and all necessary approval by the Mayor and/or notice of publication.

AN ORDINANCE ESTABLISHING THE SOLID WASTE AND RECYCLING FUND

WHEREAS, the City of Fort Wayne believes that its responsibility to provide the best services at affordable prices to its citizens is paramount; and

WHEREAS, the City of Fort Wayne Code of Ordinances, Section 50.03, established the Solid Waste Fund which currently serves as a repository for clean-up costs and missed collection liquidated damage penalty fees that are to be used for collecting, disposing and recycling of solid waste; and

WHEREAS, the current recycling contract between the City of Fort Wayne and the recycling contractor now provides revenues from the share of profits derived solely from citizens' recycling efforts; and

WHEREAS, these revenues were anticipated in the formation of said contract such that they would be used to offset the solid waste disposal and recycling costs that are incurred, through this contract, to the citizens of Fort Wayne; and

WHEREAS, these recycling revenues currently are only deposited in the General Fund and are therefore available to be spent to offset other expenses or new projects, unrelated to the citizens' solid waste and recycling costs; and

WHEREAS, in order to segregate these funds in perpetuity a fund must be established into which they are deposited;

NOW, THEREORE BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA;

SECTION 1. Section 50.03 of the Code of Ordinances for the City of Fort Wayne

will be amended to create a Solid Waste and Recycling Fund for the purpose of collecting and holding revenues from clean up costs and missed collection liquidated damage penalty fees as well as the revenues received from the City's recycling contract.

SECTION 2. These revenues so deposited in the fund created hereunder, per Section 50.03 of the Fort Wayne Code of Ordinances shall be used solely for the purpose of accounting and paying for the costs of collecting, disposing and recycling of solid waste and as such should result in the reduction of the garbage and recycling user fees paid by the City of Fort Wayne residents.

SECTION 3. These revenues deposited in the fund created hereunder shall remain in the fund until each successive year-end and will then be used to pay for the cost of collecting, disposing, and recycling solid waste in the following year which should result in an offset or reduction of garbage/recycling user fees paid by the City of Fort Wayne residents. Revenues deposited to the fund created hereunder may be used for payment for the costs of collecting, disposing, and recycling of solid waste as contemplated hereunder without requiring further action by the Common Council.

SECTION 4. That this ordinance shall be in full force and effect from and after its passage and any and all necessary approval by the Mayor.

AN ORDINANCE AMENDING SECTION 99.140 OF THE FORT WAYNE CODE OF ORDINANCES

WHEREAS, the Emerald Ash Borer has caused extensive devastation to Fort Wayne's tree canopy;

WHEREAS, white ash has been listed in City Code as a permitted street tree variety;

WHEREAS, there are numerous trees determined to be appropriate for restoration of our City's glorious tree canopy;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

99 of the Municipal Code of SECTION 1. Chapter Ordinances is hereby amended to delete Section 99.140, Paragraphs (A) and (B) VARIETY OF TREES PERMITTED TO ΒE PLANTED ALONG STREETS, in its entirety and replaced with the following:

§99.140 VARIETY OF TREES PERMITTED TO BE PLANTED ALONG STREETS.

(A) The following varieties of trees may be planted along specified streets, namely: Norway maple, crimson king maple, summer shade maple, sugar maple, red maple, freeman maple, hackberry, American linden, little leaf linden, tulip poplar, paul scarlet thorn, red oak, pin oak, white oak, scarlet oak, swamp white oak, shingle oak, English oak, Heritage oak, Regal Prince oak, Chinquapin oak, European hornbeam, American hop hornbeam, Espresso Kentucky coffee tree, sweet gum, sunburst or imperial locust, ginkgo (male), Bloodgood London plane tree, Princeton American elm, Valley Forge American elm, New Harmony American elm, Japanese Zelkova, sycamore and other trees as permitted by the Board of Park Commissioners ('74 Code § 30-5).

(B) The planting of trees other than those listed in $\S99.140(A)$ is prohibited along any street except by permission of the Board of Park Commissioners. ('74 Code, $\S30-6$).

SECTION 2. That the City is directed to take all action necessary and proper for the implementation of this Ordinance.

SECTION 3. That this Ordinance shall be in full force and effect from and after its passage and any and all necessary approval by the Mayor, but shall expire, unless action is taken to extend it, three (3) years after it becomes effective.

AN ORDINANCE amending the City of Fort Wayne Zoning Map Nos. D-11 and D-07 (Sec. 18 of Wayne Township)

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the area described as follows is hereby designated an RP (Planned Residential)

District under the terms of Chapter 157 Title XV of the Code of the City of Fort Wayne, Indiana:

Part of the Northwest Quarter and Southwest Quarter of Section 18, Township 30 North, Range 12 East of the Second Principal Meridian, Wayne Township in Allen County, Indiana, part of the Northeast Quarter of Section 13, Township 30 North, Range 11 East of the Second Principal Meridian, Aboite Township in Allen County, Indiana and part of Lot Numbered 54 in Highland Garden Addition as recorded in the plat thereof in the Office of the Recorder of Allen County, Indiana, more particularly described as follows:

to a Survey Marker Nail found on the centerline of South Bend Drive (formerly U.S. Highway #24); thence South 71 degrees 34 minutes 09 seconds West, a distance of 119.67 feet (119.0 feet deed) along said centerline to a Survey Marker Nail found; thence North 00 degrees 04 minutes 53 seconds West, a distance of 274.56 feet (274.6 feet deed) to a 1/2" steel rebar on the North line of said Lot Numbered 54 and the North line of said Southwest Quarter; thence South 89 degrees 11 minutes 40 seconds West, a distance of 384.37 feet (385.5 feet deed) along said North line and said South line to the Point of Beginning.
